

(16) <u>16.1 Subject and type</u> Guided type fall arrester including a rigid anchor line Type: GÜFA

16.2 Description

The guided type fall arrester including a rigid anchor line, type: GÜFA is intended to protect a person against falls from a height at a maximum permitted rated load of 150 kg. The minimum rated load is 50 kg. The rigid anchor line is mounted on appropriate surfaces with sufficient strength.

The rigid anchor line can be fastened to the building structure by means of fasteners (Fig. 4). The distance between the individual fasteners can vary in relation to the system design with a maximum distance of 1.68 m. In addition, the rigid anchor lines can be installed with a maximum inclination of 20° towards the building structure and sideways.

The rigid anchor line (Fig. 5-6) consists of a U-profile with different assembly lengths between 1120 mm and 2800 mm. Galvanized steel, stainless steel or aluminium could be used as material for the rigid anchor line. Optionally, there are more variants of the rigid anchor line in combination with single stile ladders or double stile ladders. Two guide profiles are connected by means of an appropriate rail joint (Fig. 11). The ends of the rigid anchor line are respectively equipped with suitable end stops (Fig. 7-9) to prevent unintended overriding.

At its running length the anchor line is provided with rectangular recesses or notches continually at regular intervals. These notches are used to accommodate the safety catches of the guided-type fall arrester.




Fig. 1-2: guided type fall arrester, type: GÜFA Flexx

The guided type fall/arrester, type GUFA 5 (Fig. 3) and GUFA Flexx (Fig. 1-2) run/on/the/rigid anchor line.

The fall arrester of type GÜFA Flexx/(Fig./1-2) is running on the anchor line, a mechanism/is in place to remove it from and place it on any given point of the anchor line.

An additional pin is attached to the side of the fall arrester. This prevents that the fall arrester together with the end stop (Fig. 7-9) at the lower end can only be placed in the direction of attachment. The base of the fall arrester bears a safety catch; to this catch an eyelet is connected for the energy absorbing element to which the connector is fastened. The energy absorbing individual part consists of a sewn webbing (w = 25 mm). The connector used is secured by means of a pin.



Fig 3: guided type fall arrester, type: GUFA 5




Fig. 4: fastener, type: rigid wall anchor




Fig. 7 - 9: end stop A, type: removable rail arrest




Fig. 10: end stop, permanent rail arrest
